 ALL dogs owned by you or residing with you must be licensed whether they are listed here or not.

**In order to process your dog's license, we must have a current rabies vaccination certificate on file.**

If expired, we require an updated rabies certificate in order to process the license. This can be provided by having your veterinarian fax a current rabies certificate to 789-1795, or by e-mail at [animalcontrol@ghspets.org](mailto:animalcontrol@ghspets.org)

License fees for altered (spayed or neutered) dogs are **\$20.00**.

License fees for unaltered (non-spayed or non-neutered) dogs are **\$45.00**.

**If the altered status of your pet is listed incorrectly, please circle the correct status above.**

Your veterinarian will be contacted for verification.

Licenses must be renewed annually beginning January 1<sup>st</sup>.

A **\$15** late fee will be added to the licensing fee if the license is not purchased prior to March 31<sup>st</sup>.

**Please check the above information carefully for accuracy and make any changes, additions or corrections as necessary.** Alternate contacts and phone numbers are particularly important when we are trying to get your dog home. Please make sure that names and current phone numbers are included.
